Walker teachers and students share ELA and math learning strategies with Board Members Walker teachers Tracy DeCesare and Jen McFarland shared learning strategies in ELA and math class with members of the Board at Wednesday night's meeting. During the math segment, Mrs. DeCesare said her students begin a lesson by exploring a concept as a group using prior knowledge. They then build on prior knowledge by going over the lesson together, practice as a class, and then practice independently. Her students demonstrated a "group explore" with each student having a specific role in their demonstration of dividing fractions using fraction strips they created. During the Language Arts segment, Mrs. McFarland and her students featured the narrative writing process. Students participated in a mock gallery walk using pictures from the book, *The Mysteries of Harris Burdick* by Chris Van Allsburg. During the demonstration, pictures were placed on the wall to simulate how students would walk around the classroom to study each picture and caption and jot down story ideas on sticky notes. The ideas are then shared to help students get started writing their narrative stories.
