## Board of Education President appoints members to committees

At the May 8 meeting, Board President Sean William Doyle appointed Board Members to several leadership roles. ## In other matters, the Board

- recognized the Summit Hill Jr. High Girls Volleyball team for participating in the IESA State Tournament;
- recognized the Summit Hill Band, Symphonic Band, and Choir for their accomplishments throughout the year;
- joined the Mokena Community Park District in recognizing Cathi McNeil for her help with the usage of the school facilities at Arbury Hills School;
- heard an update on technology needs for board meetings held at district schools;
- heard a report on the district's Financial Profile status;
- heard plans for the May 23 Staff In-Service and the May 24 Teacher Institute program;
- approved District 161 certified job descriptions related to Senate Bill 7 regulations;
- approved the bid from R.B. Crowther in the amount of \$209,000 for roof warranty work at Indian Trail School and the Administrative Center/Mary Drew School;
- authorized submission of School Maintenance Grants with ISBE;
- authorized a district wide lawn maintenance contract to be capped at \$20,735 with Bill's Lawn Maintenance;
- discussed club, band, and athletic activity fees;
- discussed providing a full-day early childhood option which allows for a full continuum of early childhood services within the district; and
- set the 12-month support staff summer schedule which runs from June 10 through August 1.
