Dr. Julian Rogus first grade teachers and students demonstrated three of the Daily 5 math center activities that are used, and Mrs. Hartley's science class presented their problem-based learning projects on saving the polar bears from global warming.

Holiday Vacation Schedule

Mrs. Rains stated that December 24, 2013, and December 31, 2013 would be observed as holidays this year for 12 month employees.

Immunization and Compliance Report
