### **Board of Education approves 2020-2021 school district calendar**

### Kindergarten registration for 2020-21 school year begins February 3

Parents may access the Summit Hill website at <a href="www.summithill.org">www.summithill.org</a> to review the checklist of documents needed for registration. Parents may register their child at Dr. Julian Rogus School, 20027 South 88th Ave. in Frankfort between 3:45 p.m. and 6:30 p.m. on February 3. Afterwards, students and parents may participate in a tour hosted by Rogus kindergarten teachers.

Parents have the option of enrolling their kindergartener in the extended day program which is from 8:45 a.m. to 2:15 p.m. or the half-day program which runs from 8:45 a.m. to 11:15 a.m. Registration fee for extended day is \$150. Registration fee for half day is \$125. Payment options are available. **A \$30 off registration fee incentive** is available for those who complete their child's registration and payment **between February 3 and February 28.** 

Parents will need to present an official birth certificate (with certification seal from the county). Students must be 5 years old on or before September 1, 2020. *If applicable*, proof of legal custody would include presentation of a court order or decree for legal guardianship, proof of legal custody through public aid documents, or proof of foster care.

To prove residency, one document must be provided from *Category 1* and two documents from *Category 2*.

### **Residency Document Checklist**

Category 2 - Provide TWO documents from this group to show proper address

- ☐ Current driver's license/state ID AND at least ONE of the following documents
- ☐ Most recent gas/electric/water bill **or** official start notice
- ☐ Current vehicle registration
- ☐ Current homeowners/renters insurance policy
- ☐ Current Department of Illinois Human Services letter (DIHS)

Upon completion of residency verification, parents will be given a username and password to access the online registration form. Parents can pay the registration fee online via credit/debit card. Yearly milk may be purchased as well. Payment plans are included in the registration form. For additional information, please call 815.469.9103.

- employed Amanda Buchanan, FMLA teacher and Cheryl Hajewski, paraprofessional;
- increased occupational therapist services from Margo Powell to .8 FTE; and
- accepted the resignation of Eric Maze.

#### In other matters, the Board

- approved the extension of the business office stipend:
- accepted the draft report, at no cost to District 161, from DLS for Section 1B-Tax impact, Section 1C-Tax impact including the high school experience, and Section 1D-Tax impact on District 161 including the purchase of LW North of the Unit District Feasibility Study as incomplete as it did not meet the requirements of the letter of agreement;
- approved the extended day kindergarten registration fee to remain at \$150 and half day kindergarten fee to remain at \$125 with a \$30 off registration fee incentive available for those who complete their child's registration and payment between February 3 and February 28;
- approved the registration fee for grades 1-8 to remain at \$150 with a \$30 off registration fee incentive for those who complete their child's registration and payment between March 16 and April 30;
- approved the student milk fee to remain at \$52.50;
- approved the mileage reimbursement rate to be 57.5 cents per mile;
- authorized the destruction of closed session audio recordings for the period of July 1, 2017 through December 31, 2017;
- approved the contract with Ivy League for its before and after school program at Dr. Julian Rogus School for the 2020-21 school year; and
