In personnel matters, the Board

- approved the employment of Tracy Bulfer as Assistant Principal at Dr. Julian Rogus School effective July 1;
- approved the employment of Cathryn Connolly, Connie Mortell, Kelly Rodriguez-Cowan, and Linda Gonzales (FMLA) as well as Jeanette Denning, ESY paraprofessional, and Bernie Swiatkowski, ESY physical therapist;
- accepted the retirement of Peggy Jelderks, learning center aide, and the resignation of Megan Mefford.

In other matters, the Board

- approved a one year contract and an extension option for two additional years with First Point Mechanical for HVAC preventative maintenance service;
- approved RCS Carpet & Tile to replace the floor tile in the Indian Trail cafeteria;
- approved A.S.A.P. Asphalt Maintenance to repair the asphalt in the back drive at Walker School;
- approved gifts from Arbury Hills School STARS in the amount of \$1,675; Dr. Julian Rogus School RESCO in the amount of \$15,025; Frankfort Square School SCO in the amount of \$9,066; Indian Trail School SCO in the amount of \$9,926; Walker School SCO in the amount of \$5,444; SHJH SCO in the amount of \$5,355; SHJH/Walker School Band Boosters in the amount of \$3,696; SHJH/Walker School Athletic Boosters in the amount of \$2,933; and Districtwide SHEF student tablets in the amount of \$65,000;
- authorized submission of the General State Aid Entitlement Claim for 2016-2017;
